Our enterprise was established in 1992 and nowadays has more than fifteen year traditions of trading and manufacturing. Traditionally Ukraine has been a grain processing and grain producing country. The climate and unique generous land provides considerable grain harvest.

Grain processing capacity of our plant is 60 tons/day. The main products are cereals in assortment (peas polished (whole, split), defatted corn grain, corn flour, millet polished, unground buckwheat. We also deliver soy, corn forage, millet, buckwheat husk. By request we can supply dried milk products, condensed whole milk with sugar, sunflower oil and other foodstuffs of Ukrainian manufacture.

According to the results of the National Business Rating the Private Production and Trading Enterprise “JNL” is the second in Ukraine in the basic activity and is the leader of the branch of industry.

The enterprise is the member of the Ukraine Chamber of Commerce and Industry, Chernihiv CCI and was included in the National nongovernment Register of Reliable Partners.

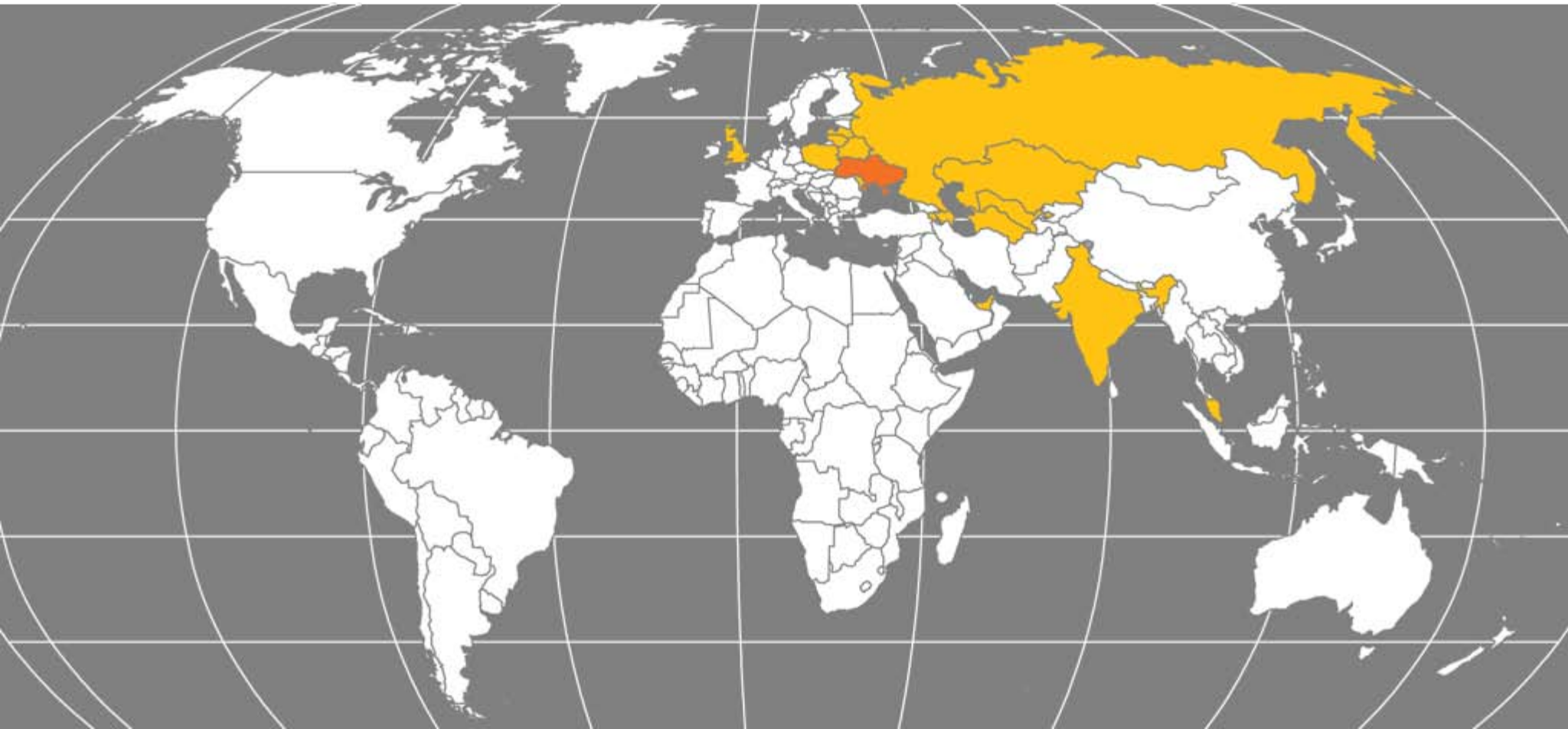

Delivery by rail transport

- DAF – Ukraine border
- DAF – border any other country
- CPT – destination station (if the client is accredited by his country railway it is cheaper for him to pay for the delivery in his country by himself. In this case it is not so expensive then if we order our forwarders the delivery in your country.)

Shipping by railway + transshipment into the containers + sea shipping

- CFR – destination port
- FAS – dispatch port (Odessa, Illichevsk)

The ships are chartering by the international forwarder “Black Sea Shipping Service Ltd.”

Shipping by railway + ferry

- CPT - dispatch port (Odessa, Illichevsk)

Our forwarders at the Ukrainian port is Closed Joint-Stock Shipping Company “Ukrferry”

The deliveries occur according to Incoterms 2000, the official rules of International trade

The forms of payment

- **Prepayment (preferably, we quote the best prices)**

In our deals with partners from Russia, Belarus, Armenia, Kazakhstan, Lithuania, Latvia, Azerbaijan, Uzbekistan, India and OAE we usually apply to prepayment. In this case you can have the lowest price than using other forms of payments, because bank expenses decrease and you obtain additional discounts. PPTTE “JNL” was included into the National Registrator of the Ukraine CCI of Reliable Partners so this fact can be a supplementary guarantee for you.

- **Prepayment + bank guarantee**

In this case everything is the same as for prepayment but after signing the contract and before you do the prepayment our bank gives you return of advance payment guarantee in case of seller’s nonfeasance of delivery in established by contract period
(Text of guarantee we agree in negotiations).

- **Letter of credit**

Irrevocable divided confirmed documentary covered letter of credit valid for the term of 90 days at the minimum. The text and terms of the l/c are specifying in the contract. We have good experience in payments by a L/C. We have a contract for documentary payments with Credit Dnepr joint-stock bank in Ukraine.

- **Deferment of payment** we use only with our regular customers.

We accept payment in US dollars and euro.
